

Report on the Global NARS Consortium (GNC) Survey

Initial Statement

GFAR has been entrusted with developing a Global NARS Consortium (GNC) based on the Declaration signed in Bangkok (March 2023) by its Regional Fora. The GNC aims to strengthen and amplify the global voice of NARS by defining them as "all public and semi-public stakeholders involved in research and development in a country, including National Agricultural Research Institutes, universities, and government laboratories".

This survey is a key step in the development of a GNC, according to the GNC implementation plan agreed with representatives of GFAR Regional Fora (RFs) meeting in Durban (June 2023). This tool enables the collection of valuable information on NARS worldwide in a systematic and efficient way.

It will also help to identify and understand the needs, opinions, priorities and expectations of the stakeholders involved in the process. The survey will inform the global NARS conference that GFAR intends to hold in 2024. The main function of the survey is to map public NARS stakeholders in each region and obtain a comprehensive picture of the perspectives of the different stakeholders on NARS. By collecting quantitative and qualitative data through structured and open-ended questions, this survey will provide a more accurate picture of the challenges, opportunities and requirements of the GNC.

The survey allows for the identification of key areas of interest and concern, as well as of the strengths and weaknesses of the NARS worldwide. By improving our understanding of the needs and preferences of relevant stakeholders, GFAR's Secretariat will be able to identify areas where targeted support for the GNC will be useful and effective strategies to address challenges identified.

In addition, the survey also seeks to promote the participation and engagement of Regional Fora by providing them with the opportunity to express their views and actively contribute to the GNC development and planning process. This will foster a collaborative approach in setting up and running the GNC.


2. How familiar are you with the research activities of public national agricultural research institutions in your region?






B. Harmonization and representation

2. If you prefer including only one umbrella NARS per country, what is your main reason for this choice?




3. If you prefer identifying several NARS in each country, what is your main reason for this?


"The reason is to have a clarity on multiple Institutions at the initial stage to have a

4. What criteria do you think should be used to select the umbrella NARS to include in the global NARS list? (Select all that apply)




5. If only one umbrella NARS is included per country, how do you consider that this would impact the accuracy and completeness of the global list?






C. Research-extension/advisory services linkages

2. How important do you consider innovation systems in shaping the success of a Global NARS Consortium in advancing agricultural research and development?


